



54 DIFFERENT LANGUAGES

- One new international resident moves here each day ¹
 - 1,825 Net International Migration (2013-2017)
- 10.1% of our Population is Foreign Born ²
- 1,300 students speak 54 unique languages in our public schools
- More than 35 Foreign Companies employ 8,900± locally
 - Sister City exchanges help EDC be better marketers to FDI prospects
- Sister City Relationship with Miyoshi is exceptionally strong
 - Education, Government, Citizen exchanges
 - We have opportunity to visit them each year when visiting HQ's
 - Schools are huge partners, annual exchanges
- Our Wuxi, China relationship helped introduce Ivy Tech Community College to a Sister College





FUNDING & STAFF RESOURCES

- No dedicated City staffing, primarily volunteer driven
- EDC offers targeted staff support and allocates some funding:
 - \$3,000 for inbound delegations
 - \$30,000 for international travel for EDC
 & Mayor primarily targeting FDI,
 secondarily to support Sister City
 relations

POLITICAL / COMMUNITY SUPPORT

- Officials actively participate
- Primary schools actively support student & teacher exchanges annually (inbound) or semi-annually (outbound); community college has also supported teacher exchanges
- Sister City committee formed for Pune, India relationship
- Friendship Alley in Columbus commemorates the Miyoshi relationship






AREAS FOR IMPROVEMENT

- In China, we said "yes" to every city who expressed interest
 - The number of relationships & distance between cities in China make follow-up visits difficult
 - Some of these relationships were not adequately built upon shared/natural bonds
 - With this experience, we now know to take these factors into consideration in the future
- Because our local EDC is the only funder in many cases (except for school exchanges), we many not always be as eager or equipped to fund non-economic development Sister City exchanges
- Dedicated funding and/or stand-alone organization for Sister City support is not present (but we manage!)


Future Plans







- Annual Japan trips
 - 37+ Years of Business Visits, with several of our companies in/near Miyoshi
 - Support school & government exchanges
- Build upon new Pune, India relationship
 - Home to Cummins R&D Center
 - Leverage relationships with KPIT, Birlasoft, and AxisCades
- Evaluate efforts in China
- Löhne Germany relationship to remain largely volunteer driven
