UNICOR's Positive Impact on Local Economies


- Companies working with UNICOR often purchase equipment, material, and services from businesses in the surrounding region
- Approx. 72% of UNICOR's revenues return to the economy from local procurement
- Nearly 50% percent of purchases are from small businesses, including businesses owned by women, minorities, and disadvantaged.
- Companies that manufacture with UNICOR can grow; then rent or build their own factories in the state, adding jobs and local tax revenue



unicor FPI benefits the U.S. economy



72 cents – Raw Materials, Equipment, Trucking, & Service Industries (Approx. 50% to small business)



23 cents - Staff Salaries



5 cents – Inmate Pay (\$1 million to families, victim restitution, etc.)

UNICOR's Two Authorities to Work with Private Companies

- Authorized by Congress in 2012
- Allow commercial companies to have their manufacturing/service work performed by UNICOR

1. Repatriation (reshoring) authority

- ▶ 18 U.S.C. §1761(d)
- UNICOR can work with companies to produce or assemble products that are currently produced, or that would otherwise be produced, outside the U.S.
- UNICOR has experience as a contract manufacturer for over 30 companies

2. Prison Industry Enhancement Certification Program (PIECP)

- ▶ 18 U.S.C. §1761(c)
- Gives UNICOR the authority to produce any commercial product for the private sector, when
 - inmates are paid the local prevailing wage
 - the work performed will not displace employed private sector workers;
- Companies can immediately move into a modern facility and manage their own operation without the capital expense of building their own factory

Commercial market services

- Examples: Call centers, data entry, sorting, distribution, and CAD/drafting services for the private sector
- Requirement: UNICOR inmates do not displace local workers

Tax Benefits

- Domestic Production Activities
 Deduction (DPAD) (IRC § 199):
 Companies may be eligible for a 9% federal income tax deduction
- Work Opportunity Tax Credit: Federal tax credit available to employers who hire individuals from certain target groups, including ex-offenders, who face significant barriers to employment

Benefits to Society



- to inmates UNICOR benefits approximately 18,000 inmate workers annually
 - Opportunity to learn marketable skill and valuable work experience that enhances their ability to reintegrate into society.
 - Teaches inmates pro-social values including the value of work, responsibility, and the need to work with others.
 - Upon release, those who participate in the program are 24% less likely to recidivate and 14% more likely to find employment, compared to individuals who did not participate.
 - Results in more productive, law-abiding citizens, intact families, and safer communities

Benefits to Society (continued)

- to taxpayers A Washington State Institute for Public Policy study concluded that correctional industries programs like UNICOR generate significant savings of taxpayer dollars.
 - For every \$1.00 spent on correctional industry programs, \$4.77 is saved in future criminal justice costs (arrests, conviction, incarceration, post-release supervision, and crime victimization) due to the reduction in recidivism among inmates who work in these programs.
- UNICOR is self-sustaining and receives no taxpayer funds for its operations

Benefits to Society (continued)

- to the courts, crime victims and families
 - Through wage deductions, victims are compensated and inmates' families are supported
 - In FY 2016 UNICOR inmates contributed nearly \$1 million—up to 50% of their earnings, toward meeting financial obligations, e.g., court—ordered fines, child support, and/or restitution. Inmates also contribute to their families by sending home a portion of their earnings.

Benefits to Society (continued)

- to the Bureau of Prisons UNICOR contributes to the safety and security of Federal correctional facilities by keeping inmates constructively occupied. Inmates participating in FPI are less likely to engage in institutional misconduct, thereby enhancing both staff and inmate safety.
- to veterans approximately 7% of the inmates employed by UNICOR are veterans. More than 200,000 veterans are incarcerated in the nation's prisons and jails.


